with the RTI application of the appellant by the respondent-Public Information Officer seriously, thus Sh. Joginder Singh, Distt. Revenue Officer-cum-Deputy Commissioner, District Ludhiana is issued a show cause notice to explain in a self-attested affidavit as to why a penalty @ Rs.250/- per day of delay subject to a maximum of Rs.25000/- till the complete information is furnished, be not imposed under Section 20(1) of RTI Act, 2005 on him for causing wilful delay/denial of the information to the RTI application and to issue show cause for compensation to the appellant for detriment suffered by him under section 19(8) of the RTI Act,2005.

In addition to the written reply, the PIO is also given an opportunity under Section 20(1) proviso thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may take a note that in case he does not file his written reply and does not avail himself of the opportunity of personal hearing on the next date, it will be presumed that he has nothing to say and the Commission will proceed ex-parte.

- 3. One last opportunity is granted to Sh. Joginder Singh, respondent-Public Information Officer to supply the complete information in this case failing which punitive action as per provisions of the RTI Act, 2005 will also be recommended in this case.
