ORDER

This order may be read with reference to the previous order dated 18.12.2020.

2. The representative of the respondents states that the remaining information, as per the directions of the Commission vide order dated 18.12.2020, pertaining to Point No. 3(iii) C of the RTI application has already been sent to the appellant duly attested by the APIO with a copy to the Commission, which is taken on record. Also the appellant states that he has received the information as per the statement given by the representative of the respondents. He has also made the submissions in this regard, which is taken on record.

3. The appellant has not made any submissions that the information supplied to him by the respondents is incomplete but he has made the other submissions regarding the ambiguities in the pay fixation of Sh. Dalbir Singh Saroya i.e. Point No.3(iii)c, done by the Financial Commissioner's Secretariat. However, the appellant is advised to approach the competent authority in this regard, if so desired, but no further directions can be given to the respondent authority as it is beyond the preview of the provisions of the RTI Act, 2005.
