This order may be read with reference to the previous order dated 11.01.2021 vide which the respondent –PIO was directed to submit penalty amount i.e. Rs. 10000/-.

2. The appellant is absent today.

3. The respondent Sh. Gautam Kumar is appearing today and has filed his reply mentioning therein that

“(ii) That the information as sought by the appellant was provided to him vide office letter dated 13.12.2019. (iii) That the deponent attended the hearing fixed by the Hon’ble State Information Commission on 16.12.2019 and apprised the Hon’ble Commission accordingly. It is humbly submitted that the appellant did not attend the hearing on that date. (iv) That the appellant attended the next date of hearing in the Hon’ble State Information Commission i.e. 07.01.2020 and expressed dissatisfaction with the information supplied to him. Hon’ble Commission after hearing both the parties directed the appellant to visit the office of the respondent on 15.01.2020 at 11.00 AM, inspect the record and obtain the information. Respondent was also directed to provide the same to the appellant. (v) That it is humbly submitted that the appellant did not visit the office as per directions of the Hon’ble State Information Commission on the said date/time. Further the appellant also did not respond to the subsequent communications of the deponent. (vi) That after skipping two dates fixed by the Hon’ble State Information Commission on 10.02.2020 and 12.03.2020, the appellant attended the hearing of the Hon’ble Commission on 15.06.2020 and again stated that no information has been provided to him so far, concealing the fact that he did not inspect the record in compliance of the orders of the Hon’ble State Information Commission dated 07.01.2020. (vii) That the deponent could not attend the hearing dated 15.06.2020 and 11.08.2020 being involved in essential services during the time of pandemic of COVID. However the deponent seeks apology for not informing the Hon’ble Commission for the same. (viii) That the deponent was transferred

from MC Moga on 04.09.2020 to MC Patiala. (ix) That the answering Respondent has the highest regard for this Hon'ble Commission and cannot in any way think of violating its order. The matter was in the process for complying with the orders of the Hon'ble Commission. The delay which has since occurred in making the requisite compliance, though not willful or intentional, is regretted and the Deponent tender's unconditional and unqualified apology for the same.

4. The perusal of the file shows that he appellant is absent for second consecutive hearing. He has not informed the Commission whether he has received the information or not. It is made clear that in case the appellant does not appear on the next date of hearing, appropriate order in his absence shall be passed.

5. After going through the reply of the respondent, it may take note that there is no provision in the Right to Information Act, 2005, which may empower the Commission to review its own decision, passed after hearing the parties on merits of the case.

6. ***The Commissioner, Municipal Corporation, Moga is again directed to ensure that this amount of penalty is deducted from the salary of the above said PIO and deposited in the Treasury under the relevant head before the next date of hearing.***
