It is appropriate to consider the instructions issued by the Ministry of Personnel, Public Grievances & Pensions, Department of Personnel & Training No. 10/2/2008-IR dated 12.6.2008 to transfer the RTI application of the appellant under Section 6(3) of the RTI Act, 2005 to 'public authority' and not to the 'public authorities'. Therefore, the request of the appellant to implead the Water Supply and Sanitation department is not tenable as the Public Information Officer o/o the Block Development and Panchayats Officer has already transferred the RTI application to the Public Information Officer-cum-Panchayat Secretary under Section 6(3) of the RTI Act, 2005 and the information has already been supplied to the appellant by the Public Information Officer-cum-Panchayat Secretary.
- 5. Accordingly, the respondent-Public Information Officer is directed to pay the compensation amount i.e. Rs.5000/- (Five thousands only) from the state exchequer to the appellant as has been awarded by the Commission before the next date of hearing. The Block Development and Panchayats Officer, Guru Harsahai is also directed to ensure that the compensation amount be paid to the appellant before the next date of hearing failing which the case will be considered for the enhancement of the compensation amount. Also the Public Information Officer-cum-Block Development and Panchayats Officer is directed to submit the response regarding the allocation and expenditure of funds related to various schemes mentioned in the website. Copy of the documents sent by the appellant are **sent** along with this order.
