

1. This order may be read with the reference of previous order dated 08.02.2021, vide which appellant was advised/ ordered to point out to **point out discrepancies** (in written form) in the information so supplied by the respondent. Accordingly the case is fixed for today.

Observation:

2. Appellant, Sh. Balbir Singh reiterated the contents of his RTI application and argued that partial information has been supplied to him so far. On this the Respondent, Sh. Manmohan Singh pleaded that he has supplied all the available records and no any other record is available in his office. He further said that he brought the complete file in the court and offered the appellant, if he wants to inspect it. The appellant agreed for the same and after going though the said file, he said that, information pertaining to few points of the RTI application are not available in the record file for which he requested to file an affidavit.

Decision:

3. The Commission has carefully considered the submissions of the parties and finds that the RTI application has been suitably replied and the information has been supplied to the best extent. Moreover, the present respondent PIO, is directed to submit an affidavit indicating that the non availability of the partial information which is being solicited by the appellant.

Accordingly the case is **disposed of** and **closed**.
