Even then in case the appellant feels that any part of information is not attested, then he can visit the office of the PIO and request the PIO to attest the un-attested pages and the PIO is directed that in case the appellant comes to his office for attestation of un-attested pages, then provide him attested pages.

So, the present appeal case is disposed of and closed with the observation that in case the appellant feels that some pages are un-attested, then he should visit the office of the PIO for attestation of those pages within 15 days.

With this observation the present appeal case is **disposed of and closed**.
