1. The RTI application is dated 01.10.2019 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 26.11.2020 and the second appeal was filed in the Commission on 19.02.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. Notice of hearing was issued to the parties for 15.06.2020 by the Commission through Video Conferencing facility in the office of D.C. Ludhiana.
3. Shri Nitin Kumar Garg, appellant attends the hearing through V.C. He states that the information sought by him has not been provided and denied under Section 8(1)(j) of the RTI Act,2005.
4. Neither the appellant himself comes present to attend the hearing through VC nor has sent any of his representative to attend the hearing.
5. The Bench examines the RTI Application of the appellant in detail and observes that information sought by him is related specifically to Superintendent Shri Vivek Verma of Municipal Corporation, Ludhiana. This information has no relationship to any public activity or interest and has, thus, been correctly denied under Section 8(1)(j) of the RTI Act,2005.

Though Sh.Parshotam Lal assures to supply the information, but being PIO of all Zones, Shri Tejinderpal Singh, PIO is directed to ensure that complete information is provided to the appellant with the stipulated time.
