

On not receiving information from the PIO or on filing First Appeal with the First Appealate Authority (hereinafter FAA) on 12.03.2021, the Appellant filed Second Appeal in the Commission on 28.07.2021 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and as such Notice of hearing was issued to the parties.
- 3. The case has been heard today. The PIO filed his reply which was received in the Commission vide diary no. 4705 dated 08.03.2022 mentioning as under: -

Reply on behalf of Respondent No. 1 & 2 is as under:-

- 1. The petitioner than filed appeal before appellate authority for not providing information demanded by him.
- 2. Thereafter after due preparation of photocopies of record, this office has sent the requisite record demanded by the applicant vide this office letter no. 270 dt. 22-04-2021 which was delivered by hand to the applicant on dt. 26-04-2021. The applicant had given proper receiving of the record after appending his signatures. The receiving of the applicant is enclosed herewith(Annexure-3)
- Thereafter this office sent report to First Appellate Authority regarding delivery of record and receiving received from the applicant was also sent vide this office letter no. 75 dt. 27-04-2021(Annexure-4)
- 4. Thereafter the applicant sent letters on 27.04.2021 and 19-05-2021 that information sent to him vide this office letter no. 270 dt. 22-04-2021 was incomplete, without mentioning any detail in this regard. 4. After going through the reply of the PIO, it is ascertained that the appellant has already been in possession of the requisite information. The Bench also observes that the appellant instead of depositing fee as demanded by the PIO, has preferred Appeal wrongly stating that the fee was to be demanded within 10 days which is in fact 30 days.

5. After perusal of the case file, the Bench observes that sufficient information/reply has already been supplied to the appellant. As the Appellant is absent and nothing has been heard from him regarding the receipt of information, it is presumed that he is satisfied with the response provided by the PIO. However, the appellant is advised to file fresh RTI application if anything is left in above said matter.
