

As the information-seeker has suffered detriments on account of attending the hearings in this case, a compensation of Rs. 5000/- (Rupees Five Thousand only) is awarded to the appellant, Sh. Sukhwinder Singh. The compensation shall be paid by public authority concerned by way of crossed cheque/Demand Draft in the name of Sukhwinder Singh. The crossed cheque/Demand Draft shall be made from the bank account of public authority concerned and not from the individual official.

The respondent PIO is also directed to submit a copy of the cheque/Demand Draft to the Commission by or on the next date of hearing to establish the fact that order of the Commission has been complied with.
