1. This order may be read with reference to the order dated 29.07.2020 passed by this Bench on the previous date of hearing.
2. The case has been heard today through V.C. at DC Office, Ludhiana. Shri Ravinderpal Singh, appellant comes present. He states that he had sought information regarding depth permitted for construction of basement of a building and for construction of parking by Municipal Corporation, Ludhiana.
3. Shri Harjit Singh, Building Inspector comes present to attend the hearing on behalf of the PIO. He states that the reply to the RTI application by Zone-B of Municipal Corporation, has been given vide letter dated 27.07.2020 stating therein that the building by-laws with regard to the construction of buildings/parking are available on the website of the Municipal Corporation, which can be accessed.
4. The Bench, post deliberations and after perusing the RTI application, notwithstanding that information sought is available on official website, directs the PIO, Zone-B, Municipal Corporation, Ludhiana to make available to the appellant a hard copy of the relevant document, indicating specific dimensions of depth permissible under the bye-laws for construction of basement and parkings, within next seven days.
