## Appeal Case No. 3933 of 2021 (Under Life & Liberty) Through CISCO WEBEX

## **ORDER:**

- 1. The RTI application is dated 31.08.2021 vide which the appellant has sought information as enumerated in his RTI application Section 7(1) of the RTI Act, 2005 (under Life & Liberty). First appeal was filed with the First Appellate Authority (hereinafter FAA) on 02.09.2021 and second appeal was filed in the Commission on 08.09.2021 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

- 4. On this, appellant, Sh. Gurinder Singh, appellant states that demanded information relates with him and pleads the court for directions to the respondent department to provide the requisite information.
