But the SPIO is absent today and neither he has provided the information and compensation to the appellant. So, the amount of compensation of Rs.3,000/- is enhanced to Rs.5,000/- and the SPIO is directed to send the amount of compensation of Rs.5,000/- to the appellant from the funds of public authority by way of demand draft and be sent through registered post within 10 days along with attested copies of sought for information and compliance be sent to the Commission accordingly. In case of non compliance of the Order of the Commission a Show Cause Notice U/s 20(1) of the RTI Act, 2005 will be issued to the SPIO and he will be penalized upto Rs.25,000/-, which will be deducted from his salary.

ORDER

Shri Jang Bahadur, appellant filed RTI application dated 28.07.2020 before the SPIO, O/o BDPO, Jalalabad. The RTI application was transferred U/s 6(3) of the RTI Act, 2005 to the PIO, O/o Panchayat Secretary, Gram Panchayat, Mandi Amin Ganj, Distt. Fazilka vide letter no.1880 dated 07.09.2020.

# Today the case is heard through CISCO Webex Meetings Software.

The appellant is present today, whereas none has appeared on behalf of the PIO. The appellant stated that the sought for information has not been provided to him.

I have gone through the previous Orders passed by the Commission. Shri Gurjinder Singh, BDPO, Jalalabad was present on 25.02.2021 and he was directed to provide the information to the applicant. Then the BDPO directed Shri Chander Bhan, PIO-cum-Panchayat Secretary, Gram Panchayat, Mandi Amin Ganj to provide the information to the applicant. The said Panchayat Secretary-cum-PIO neither has come present before the Commission nor sent any mail, whereas a show cause notice has already been issued to him vide Order dated 12.05.2021 that why he has not provided the sought for information to the applicant within the stipulated period and so why he may not be penalized under the provisions of the RTI Act, 2005.

Today again Shri Chander Bhan, PIO-cum-Panchayat Secretary is absent and neither he has sent any reply to the show cause notice nor provided the information to the appellant.

The appellant has filed RTI application on 28.07.2020 and a period of more than one year has been passed, but the PIO has not provided the sought for information to the appellant. The appellant is suffering from the hands of the PIO. So, a compensation of Rs.3,000/- is awarded in favour of the appellant to be paid by the PIO from the funds of the

public authority by way of Demand Draft and be sent to the appellant through registered post within 15 days along with attested copies of information, specifically point-wise.

A last and final opportunity is granted to Shri Chander Bhan, PIO-cum-Panchayat Secretary to file reply to the show cause notice in writing and send the same to the Commission within 15 days and an opportunity of personal hearing will be afforded to him on the show cause notice on the next date of hearing. In case he would not file any reply to the Show Cause Notice, then it will be assumed that he do not want to say anything in his defense and the Show Cause Notice will be decided on the basis of papers available in the file and a penalty of Rs. 25,000/- will be imposed upon him which will be deducted from his salary.

Both the parties should personally attend the hearing on **01.11.2021** at **11:30** A.M. through CISCO WEBEX MEETINGS Software (Meeting No. 1582695783).
