This order may be read with reference to the previous order dated 11.09.2018 vide which the respondents were directed to deliver copy of letter dated 23.01.2018 and inspection of relevant record be allowed to the representative of the appellant to identify the documents required by him and after identification the same be provided to him on the spot. The case was adjourned to 15.10.2018, which was further postponed for today due to administrative reasons.

2. The representative of the respondent-PIO submits copies of bills for purchase of medicines attested by Dr. C.B. Singh to the appellant during the hearing.

- 3. In compliance to the previous order dated 11.09.2018, the appellant states that he has inspected the concerned record, but original bills of purchase of medicines were not available in the record of the respondents.
- 4. It is a very serious case, in which the Corporation has been receiving bills for purchase of medicines etc. to deal with very important aspect of handling stray dogs, which are causing lots of inconvenience to the residents of Municipal Town, Mohali.
- 5. Commissioner-cum-PIO Shri Sarabjit Singh, Assistant submits photocopies of bills which are duly verified by the concerned Dr. C.B. Singh, whose contract is since expired. He further states that original bills are not available in their record as no payment has been made against them. But this is no excuse. The bills, which are submitted to the Municipal Corporation, Mohali, are not supposed to be lost or treated as property of any individual officer. These bills needs to be got traced in their original shape and then action needs to be taken ensuring transparency and accountability as per the provisions of the RTI Act, 2005. The findings need to be concluded and shared with the Commission. The Commissioner, Municipal Corporation Mohali is directed to look into the whole episode and make a report in the period of two months.
- 6. The appellant has been seeking information since 11.12.2016 and there is a loss of about 735 days, so far, for not supplying him the right kind of information. This has resulted in much avoidable inconvenience and hardship to the Appellant. He is, therefore, entitled to be compensated under Section 19(8)(b) of RTI Act 2005 for the

loss and detriment suffered by him. In the circumstances, I am of the view that ends of

justice would be met if a sum of Rs.5000/- (Rupees Five Thousand Only) is awarded to

the Appellant as compensation. I order accordingly.

7. This amount shall be payable by the Respondent from the State

exchequer within fifteen days from the receipt of this order under intimation to the

Commission.

8. Looking at the callous, lackadaisical and highly irresponsible attitude of

the respondents, Shri Sarabjit Singh, Assistant Commissioner-cum-PIO is issued a

Show Cause notice under Section 20 of the Right to Information Act, 2005 as to why

penalty of Rs.250.00 per day and subject to maximum of Rs.25000/- may not be

imposed on him for his failure to give the information within the stipulated time. In case

he wants to give any justification for delay, he may file his reply before the next date of

hearing.

That the appellant had filed 1st Appeal which was also disposed of vide order in Appeal No.5 of 2018 dated 12.07.2018 and the answer sheets of the paper of appellant was also shown to the appellant by the PIO in his room on 12.07.2018 as ordered by the FAA with the assistance of Sh. Harbans Singh, Chief Reporter and Sh. Gurkirat Singh, Senior Reporter. She compared her answersheets with the question paper and expressed her satisfaction at that time but refused to give in writing that she had seen her shorthand papers.

That the question involves in the present appeal is that respondent did not supply the answersheets of other candidates.

That the answersheets of other candidates are exempted under Section 8(1)(j) of the RTI Act being personal information. In a similar case, the Hon'ble Punjab and Haryana High Court in CWP 3099 of 2013 "Yadwinder Singh Versus Punjab Public Service Commission", has held that the copies of the answersheets of other candidates cannot be supplied. The relevant paragraph of the judgment of this case is reproduced as under:-

"Admittedly, the copy of the answer sheet of the petitioner has already been supplied to him. By way of present writ petition, petitioner seeks information i.e. copies of answer sheets pertaining to other candidates, who participated in the selection process with the petitioner. A careful perusal of the judgment of the Hon'ble Supreme Court in Aditya Bandopadhyay's case (Supre) would show that the Hon'ble Supreme Court held entitled only the examinees to have inspection of their answer

books. No examinee was held entitled to inspect the answer books of other candidates".

After hearing both the parties and going through the reply filed by the respondents, it is revealed that as per the judgment of Hon'ble Apex Court and Hon'ble Punjab and Haryana High Court, no copies of answer sheets of other candidates have to be supplied to the appellant. The appellant states that she has some judgments, in which the Hon'ble Courts have decided to give copies of answer sheets of other candidates, who participated in selection process. The appellant is advised to send counter reply to the above said reply with other judgments to justify her stand as early as possible to the respondents. On receipt of the same from the appellant, the respondents are directed to file their stand in the Commission before the next date of hearing.
