ORDER

Heard through facility of Software/application 'CISCO Webex Meetings'.
The RTI request is dated 21.01.2021. First appeal is dated 22.02.2021. Second
appeal has been received in the Commission on 04.05.2021.

On the last date of hearing, held on 25.08.2021 ;

- i) Sh. Maanveer Singh Sidhu, Senior Assistant-cum-APIO, stated that the certified copies of the requisite information of eight hundred and twenty seven pages was sent to the appellant vide letter no. 978 dated 24.08.2021.
- ii) The appellant stated that he has received the information at point no. 01 of the RTI request and information at point no. 02 is pending.
- iii) As the information was sent by the respondent PIO to the appellant vide letter dated 24.08.2021 (on the same day of hearing), which was yet to be received by the appellant.
