ORDER

The above titled case was disposed of on 30.10.2019 but the issue regarding show cause notice issued to Sh. Kiranpal Singh, Panchayat Secretary remained pending for which the case was re-fixed for hearing today i.e. 15.12.2020.

2. Sh. Kiranpal Singh, Panchayat Secretary states that the appellant has filed the number of RTI applications so due to confusion the delay has occurred. He has also filed the written reply of the show cause notice issued to him by way of an affidavit. He also assured that the RTI application will be dealt by him in the time bound manner as per the provisions of the RTI Act, 2005.

3. According to the written/oral submissions of the respondent-Public Information Officer, a show cause notice issued to Sh. Kiranpal Singh, Panchayat Secretary is hereby withdrawn. However, he is advised to remain careful in future while dealing with the RTI application(s). Since the information has already been supplied to the appellant no further action is required in this case.

ORDER

This order may be read with reference to the previous order dated 29.10.2020.

2. The appellant has sought the following information:-

"ਸ੍ਰੀ ਸੋਹਣ ਲਾਲ ਪੁੱਤਰ ਸ੍ਰੀ ਹੁਕਮ ਚੰਦ ਅਤੇ ਸ੍ਰੀ ਮਹਾਂਵੀਰ ਸਿੰਘ ਮਾਲੀ ਦੇ ਨਿਯੁਕਤੀ ਪੱਤਰਾਂ ਦੀਆਂ ਕਾਪੀਆਂ, ਸੇਵਾ ਪੱਤਰੀਆਂ ਵਿੱਚ ਕੀਤੇ ਨਿਯੁਕਤੀ ਦੇ ਇੰਦਰਾਜ ਦੀਆਂ ਕਾਪੀਆਂ ਅਤੇ ਸੋਹਣ ਲਾਲ ਨੂੰ ਮਹਾਂਵੀਰ ਦੀ ਨਿਯੁਕਤੀ ਦੀ ਮਿਤੀ ਤੋਂ ਦਿੱਤੇ ਬਕਾਏ ਅਤੇ ਉਸ ਤੇ ਦਿੱਤੇ ਵਿਆਜ ਦਾ ਵੇਰਵਾ (ਬਿੱਲ ਦੀ ਕਾਪੀ)"

3. The representative of the respondents states that the complete information has been supplied to the appellant. He has also sent a letter in this regard, which is taken on record. However, the appellant states that he has received the complete information but there are ambiguities in the information so supplied by the respondents. He further states that the arrear in compliance with the orders of the Hon'ble Court has been given to both the employees from 31.3.2001 whereas both the employees are eligible to get the arrear since the date of his joining i.e. 27.7.1994.

4. Regarding the enhancement of the arrear, it is beyond the scope of the provisions of the RTI Act, 2005 therefore, no directions can be passed in this regard. However, the appellant is advised to make the application afresh to the concerned authorities regarding the payment of pending arrear, if any. Accordingly, the Commission opines that no further action is required in this case as the complete information has been supplied to the appellant. Hence, the case is disposed of and closed.
