ORDER

1. This order may be read with reference to the previous order dated 12.10.2020 vide which appellant, Sh. Jagshir Singh intimated the Commission that requisite information is still pending from the respondent PIO.

Respondent PIO was not present for hearing and it was observed that an email dated 05.10.2020 was received by the undersigned bench from email ID rtibranchldh@gmail.com comprising a letter no. 1793/20 dated 01.10.2020 along with enclosures stating that requisite information relates with office of DCP, Amritsar.

It was also observed that Notice of hearing was sent to the respondent PIO, O/o DCP, Ludhiana instead of respondent PIO, O/o DCP, Amritsar inadvertently. A copy of previous order was sent to respondent PIO, O/o DCP, Amritsar by name along with RTI Application through registered post for his ready reference.

Respondent PIO was directed to appear in person on the next date of hearing along with directions to supply the requisite information to the appellant before the next date of hearing positively. Matter was adjourned for further hearing on 15.12.2020 i.e. today.

2. In today's hearing, appellant, Sh. Jagshir Singh is present for today's hearing states that requisite information is still pending from the respondent PIO.

3. On this, respondent, Sh. Surinder Singh states that requisite information is not compiled at one place and as per previous Order of the Commission dated 11.01.2018 passed by the then Hon'ble Chief Information Commissioner, Punjab, Sh. S. S. Channy through which it is clearly mentioned that no public authority is supposed to create, collate or generate information under the RTI Act on the asking of the information-seeker.

4. After hearing both the parties and examining the documents placed on record, it is observed that respondent had already been supplied reply to the appellant thrice through vide letter no. 2217/RTI dated 24.07.2020, letter no. 1761/RTI dated 30.06.2020 and letter no. 4098/RTI dated 16.11.2020, which is sufficient and satisfactory. Therefore, no cause of action is required in this case. Hence, the instant appeal case is **disposed of & closed**.

ORDER

1. This order may be read with reference to the previous order dated 12.10.2020 vide which appellant, Sh. Jasbir Singh stated that requisite information is still pending from the respondent PIO. He added that not even a single paper has been supplied to him till date.

Respondent PIO was absent without any intimation to the Commission. Another opportunity was given to the respondent PIO to appear in person on the next date of hearing along with directions to supply the requisite information to the appellant before the next date of hearing positively, failing to which stern action will be initiated against him as per RTI Act, 2005.

A copy of previous order was sent to him by name through registered post for his ready reference. Matter was adjourned for further hearing on 15.12.2020 i.e. today.

2. In today's hearing, respondent, ASI, Roor Singh states that appellant demanded the following information through RTI application dated 20.01.2020:

- (1):- ਸ਼੍ਰੀ ਮਾਨ ਜੀ ਦੈਨਿਕ ਜਾਗਰਣ ਅਖਬਾਰ ਨੇ ਮਿਤੀ-28/11/2019 ਨੂੰ ਇਕ ਖੱਬਰ ਸਿਰਲੇਖ “ ਵੈਸ਼ਣੋ ਦੇਵੀ ਯਾਤਰਾ ਤੇ ਵਾਪਸ ਆ ਰਹੀ ਪਾਣੀਪੱਤ ਦੇ ਸਕੂਲ ਦੀ ਬਸ ਟਰੱਕ ਨਾਲ ਟਕਰਾਈ, 9 ਜੱਖਮੀ ” ਹੇਠ ਪ੍ਰਕਾਸ਼ਿਤ ਕਿਤੀ ਗਈ। ਉਕਤ ਕੇਸ ਵਿੱਚ ਪੁਲਿਸ ਵੱਲੋਂ ਦਰਜ ਕੀਤੀ ਐਫ.ਆਈ.ਆਰ ਦੀ ਤਸਦੀਕਸ਼ੁਦਾ ਕਾਪੀ ਦਿੱਤੀ ਜਾਵੇ।
- (2):- ਸ਼੍ਰੀ ਮਾਨ ਜੀ ਉਕਤ ਕੇਸ ਵਿੱਚ ਟਰੱਕ ਤੇ ਬਸ ਦਾ ਰਜਿਸਟੇਸ਼ਨ ਸੈਟਿਫਿਕੇਟਸ ਦੀ ਤਸਦੀਕਸ਼ੁਦਾ ਕਾਪੀ ਦਿੱਤੀ ਜਾਵੇ।
- (3):- ਸ਼੍ਰੀ ਮਾਨ ਜੀ ਉਕਤ ਕੇਸ ਵਿੱਚ ਟਰੱਕ ਤੇ ਬਸ ਵਿੱਚ ਸਪੀਡ ਗਵਰਨਰ ਲਗਾ ਹੋਇਆ ਸੀ ਜਾਂ ਨਹੀ, ਸਪੀਡ ਗਵਰਨਰ ਤੇ ਟ੍ਰਾਂਸਪੋਰਟ ਵਿਭਾਗ ਦੀ ਸੀਲ ਲਗੀ ਹੋਈ ਹੈ ਜਾਂ ਨਹੀ, ਉਸ ਦੀ ਤਸਦੀਕਸ਼ੁਦਾ ਸੂਚਨਾ ਦਿੱਤੀ ਜਾਵੇ।
- (4):- ਸ਼੍ਰੀ ਮਾਨ ਜੀ ਟਰੱਕ ਤੇ ਬਸ ਨੂੰ ਬੋਰਡ ਆਫ ਇੰਸਪੈਕਸ਼ਨ (ਟ੍ਰਾਂਸਪੋਰਟ ਵਿਭਾਗ) ਵੱਲੋਂ ਜਾਰੀ ਕਿਤੇ ਫਿਟਨਸ ਸੈਟਿਫਿਕੇਟਸ ਦੀ ਤਸਦੀਕਸ਼ੁਦਾ ਕਾਪੀ ਦਿੱਤੀ ਜਾਵੇ।
- (5):- ਸ਼੍ਰੀ ਮਾਨ ਜੀ ਟਰੱਕ ਤੇ ਬਸ ਦੀ ਇੰਸੂਰੇਨਸ (ਬੀਮਾ) ਦੀ ਤਸਦੀਕਸ਼ੁਦਾ ਕਾਪੀ ਦਿੱਤੀ ਜਾਵੇ।

He added that reply relates with RTI application has been supplied to the appellant through letter no. 1258 dated 24.11.2020 stating as follows:

ਉਪਰੋਕਤ ਵਿਸ਼ਾ ਦੇ ਸਬੰਧ ਵਿੱਚ ਆਪ ਨੂੰ ਲਿਖਿਆ ਜਾਂਦਾ ਹੈ ਕਿ ਆਪ ਵੱਲੋਂ ਸੂਚਨਾ ਅਧਿਕਾਰ ਐਕਟ-2005 ਤਹਿਤ ਸੂਚਨਾ ਹਾਸਲ ਕਰਨ ਲਈ ਮਾਨਯੋਗ ਰਾਜ ਸੂਚਨਾ ਕਮਿਸ਼ਨ, ਪੰਜਾਬ, ਚੰਡੀਗੜ੍ਹ ਜੀ ਦੇ ਦਫਤਰ ਵਿਖੇ ਭੇਜੀ ਅਪੀਲ ਹੁਕਮ ਨੰਬਰ 27770 ਮਿਤੀ 20.10.2020 ਨਾਲ ਇਸ ਦਫਤਰ ਵਿੱਚ ਮਿਤੀ 27.10.2020 ਨੂੰ ਪ੍ਰਾਪਤ ਹੋਈ ਹੈ। ਆਪ ਨੇ ਆਪਣੇ ਮੰਗ ਵਿੱਚ ਮਿਤੀ 28.11.2019 ਨੂੰ ਦਿੱਤੀ ਦਰਖਾਸਤ ਇੱਕ ਖਬਰ ਸਿਰਲੇਖ "ਵੈਸ਼ਨੂੰ ਦੇਵੀ ਯਾਤਰਾ ਤੋਂ ਵਾਪਸ ਆ ਰਹੀ ਪਾਣੀਪਤ ਦੇ ਸਕੂਲ ਦੀ ਬੱਸ ਟਰੱਕ ਨਾਲ ਟਕਰਾਈ 9 ਜਖਮੀ" ਸਬੰਧੀ ਸੂਚਨਾ ਦੀ ਮੰਗ ਕੀਤੀ ਸੀ। ਜਿਸ ਸਬੰਧੀ ਇਸ ਦਫਤਰ ਵੱਲੋਂ ਮੁੱਖ ਅਫਸਰ, ਥਾਣਾ ਸਦਰ ਖੰਨਾ ਨੂੰ ਪੱਤਰ ਨੰਬਰ 138/ਆਰ.ਟੀ.ਆਈ ਮਿਤੀ 24.01.2020 ਭੇਜ ਕੇ ਆਪ ਦੇ ਮੰਗ ਪੱਤਰ ਅਨੁਸਾਰ ਸੂਚਨਾ ਦੀ ਮੰਗ ਕੀਤੀ ਸੀ। ਮੁੱਖ ਅਫਸਰ, ਥਾਣਾ ਸਦਰ ਖੰਨਾ ਦੀ ਰਿਪੋਰਟ ਅਨੁਸਾਰ ਥਾਣਾ ਸਦਰ ਦੇ ਰਿਕਾਰਡ ਮੁਤਾਬਿਕ ਮਿਤੀ 28.11.2019 ਦੀ ਖਬਰ ਸਬੰਧੀ ਕੋਈ ਐਫ.ਆਈ.ਆਰ ਦਰਜ ਨਹੀਂ ਹੋਈ ਹੈ ਅਤੇ ਨਾ ਹੀ ਇਸ ਸਬੰਧੀ ਕੋਈ ਦਰਖਾਸਤ ਪ੍ਰਾਪਤ ਹੋਈ ਹੈ। ਇਸ ਤੋਂ ਇਲਾਵਾ ਆਪ ਵੱਲੋਂ ਭੇਜੀ ਜਾਗਰਣ ਸਿਟੀ ਲੁਧਿਆਣਾ ਦੇ ਅਖਵਾਰ ਦੀ ਕਟਿੰਗ ਮੁਤਾਬਿਕ ਖਬਰ ਵਿੱਚ ਵੀ ਮੁੱਖ ਅਫਸਰ ਥਾਣਾ ਸਦਰ ਖੰਨਾ ਇੰਸਪੈਕਟਰ ਬਲਜਿੰਦਰ ਸਿੰਘ ਵੱਲੋਂ ਪੁਸ਼ਟੀ ਕਰਦੇ ਹੋਏ ਦੱਸਿਆ ਗਿਆ ਹੈ ਕਿ ਥਾਣਾ ਸਦਰ ਖੰਨਾ ਵਿੱਚ ਨਾ ਹੀ ਕੋਈ ਸਕਾਇਟ ਪ੍ਰਾਪਤ ਹੋਈ ਹੈ ਅਤੇ ਨਾ ਹੀ ਕੋਈ ਐਫ.ਆਈ.ਆਰ. ਦਰਜ ਹੋਈ ਹੈ।

3. Appellant, Sh. Jasbir Singh is present for today's hearing.
4. After hearing the respondent and examining the case file, it is observed that sufficient reply had already been supplied to the appellant, which fulfills all the aspects of the RTI application. Therefore, no cause of action is required in this case. Hence, the instant appeal case is **disposed of & closed.**
