**ORDER**

- 2. The appellant has sought the following information:-
  - Names only of MLAs who has been provided Govt vehicles.
  - Qty or amount of fuel provided by the Govt for running of vehicles provided to MLAs from 01.04.2017 to date 31.07.2021.
  - Names of MLAs in present assembly who are using own vehicles and the amount provided for running own car and limit.
  - Number of vehicles purchased for MLAs in present assembly from 01.04.2017 to date 31.07.2021 and provided to MLAs.
  - Present salary to MLAs and present DA along with allowances to MLAs
  - Names only of MLAs alongwith amount received by them repair work of vehicles used by them in present assembly from 01.04.2017 to date 31.07.2021
  - 7. Who is the transferee officer in your department ?
  - Name of first appellant authority in case information is not supplied.
- 3. The Public Information Officer o/o the State Transport Commissioner sent the specific reply concerning Point No. 1,2,4 & 6 the RTI application of the appellant, which is reproduced below:-

- 4. A copy of the information so received from the respondent-Public Information Officer has also been sent by the office to the appellant through his whatsapp number. After going through the same, the appellant states that he is out of station. Also no response has been received from the appellant in this regard.
- 5. Since, the respondent-Public Information Officer has filed the specific reply concerning the RTI application pertaining remaining Point No. 1,2,4 & 6 of the RTI application and the reply filed by her is accepted as no response has been received from the appellant. Therefore, the Commission is of the view that no further action is required to be taken in this case. Hence, the case is disposed of and closed. A copy of the information so received from the respondent-Public Information Officer is also being **sent** to the appellant along with this order.
