Vide RTI application dated 31.05.2021, the Appellant has demanded certain information from the PIO as enumerated in the RTI Application. He filed first appeal in the O/o the FAA (hereinafter called as First Appellate Authority) on 09.07.2021 and on not getting any information he filed second appeal under Section 19 of RTI Act 2005 (hereinafter called as Right to Information Act) in the Commission on 11.10.2021. Notice of hearing to the parties was issued for 16.12.2021.

2. The Appellant states that information has not been provided by the respondents.
3. The PIO is absent today. He is directed to submit his written submission in response to the Notice of Commission, before the next date of hearing failing which strict action follows. He is further directed to be present on the next date of hearing.
