1. The RTI application is dated 12.12.2019 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 03.02.2020 and second appeal was filed in the Commission on 07.12.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for personal hearing on 02.12.2020.
2. Notice of hearing was issued to the parties for 16.02.2021 through hearing in the Commission but heard through CISCO Webex application.
3. Representative of the appellant, Advocate, Sh. J.S. Ahluwalia states that requisite information relates with point no. 1 and 2 is still pending from the respondent PIO and satisfied with the supplied information in connection with point no. 3.
4. On this, respondent, Sh. Rajesh Kumar states that record has already been scrutinized but demanded information has not been found. He added that a circular has also been issued in this regard. He further added that he has sent an reply in this regard to the Commission dated 05.02.2021 (received in the Commission vide diary number 2801 dated 05.02.2021) stating as follows:
