Both the parties are present today. The respondent stated that 26 pages of information were provided to the appellant on 09.10.2020 and now 70 pages of information were provided to the appellant by hand on 04.02.2021.

The appellant stated that partial information has been provided to him by the SPIO.

So, the appellant is directed that he should submit the discrepancies in writing to the notice of the SPIO within 5 days and the SPIO is further directed that in case the appellant would submit the discrepancies to his notice, then he should provide the attested copies of information regarding the discrepancies to the appellant within a week from the receipt of discrepancies and compliance be sent to the Commission accordingly.
