#### **ORDER**

# (Heard through Video Conferencing)

- 1. This order may be read with reference to the order dated 25.11.2020 passed by this Bench on the previous date of hearing.
- 2. The case has been heard today V.C. in D.C. Office, Ludhiana. Shri Rajesh Gupta comes present to attend the hearing through V.C. He states that he has not received any information from the PIO.
- 3. Shri Rama Shankar, Clerk O/o Ludhiana Improvement Trust, Ludhiana comes present to attend the hearing through V.C. on behalf of the PIO. He states that the appellant has been supplied information vide letter dated 12.02.2021 by registered post. On the asking of the Bench, as to whether the appellant was called to the office to inspect the official records as also to identify the information required by him, he replies in negative.
- 4. The Bench observes that the information sent on 12.02.2021 has still not been received by the appellant. The Bench further observes that the PIO has not complied with the directions given by the Bench on the previous hearing in letter and spirit. As such, he has shown casual approach towards the directions of Bench which is viewed adversely.

- 5. The PIO, O/o Chairman, Improvement Trust, Ludhiana is issued show cause notice to explain as to why action should not be taken against him and also as to why penalty should not be imposed in the instant case for non-compliance of the directions given by the Bench during the previous hearing. He is also directed to file a written reply to the show cause notice as to why the appellant should not be compensated for the mental harassment suffered by him in getting the information.
- 6. In addition to the written reply, PIO is hereby given an opportunity u/s 20(1) proviso thereto for a personal hearing before the imposition of such a penalty, on the next date of hearing. He may take note that in case does not file the written reply and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceeding against him ex-parte.
- 7. The Bench again directs the PIO to call the appellant to his office and allow the appellant access to the official records. The appellant will identify the information on inspection of the official records. The PIO will provide the same to the appellant before next hearing. The PIO is also directed to file an affidavit as per directions given during the previous hearing. Original copy of the affidavit be sent to the appellant and photocopy of the same be sent to the Commission for record.
- 8. With the aforesaid directions, the matter is adjourned. To come up for hearing on 04.05.2021 at 11.30 before the Bench in Commission's office at Chandigarh. Copies of order be given to the concerned parties.
