When no information was provided to him by the SPIO, then he filed First Appeal before the First Appellate Authority on 17.09.2020. Then the appellant filed Second Appeal before the Punjab State Information Commission on 23.11.2020. The case was registered and allocated to the Bench. Notice of hearing was issued to both the parties for today **through CISCO Webex Meetings Software.**

The appellant is absent today, whereas the respondent is present on behalf of the SPIO and he stated that the sought for information has been provided to the appellant on 08.02.2021 and the appellant is satisfied with the information and he has executed a duly signed written submission after receiving the information.

The Commission has received a mail sent by the SPIO on 10.02.2021, diarized vide no.3203, which is a copy of letter no.241 dated 08.02.2021 along with a copy of duly signed written submission dated 08.02.2021 executed by Shri Ranjit Singh, appellant. I have gone through the written submission of the appellant and he has submitted that he has received 818 pages of information from the office of the SPIO and he is satisfied with the information.

As the SPIO has provided the sought for information to the appellant and the appellant himself has executed the written submission that he has received the information and he is satisfied, so the present appeal case is **disposed of and closed.**
