But the appellant was not satisfied , hence on the request of the appellant the appeal was adjourned to the next date i.e. 16.03.2022.

2. Today , the appellant states that she is not satisfied.
3. The respondent states that he has brought an affidavit today in the Commission, which is as under:-

"That it is further respectfully submitted that in the year of 1988-89 compassionate appointments being offered to the wards of deceased government employee and some other categories were governed and regulated by the instructions issued by the Department of Personnel and Administrative Reforms contained in its circular letter No. 18/14/86/5PP(1703)5964, dated 24.04.1986. A copy of the said instructions is being appended at Annexure R-1 hereto for the kind perusal of this Hon'ble Commission. The said instructions were in vogue in the year of 1988-89 as well.

That it is further respectfully submitted that the Department of the Personnel and Administrative Reforms issued instructions contained in circular letter No. 4/17/79-1PP/9977 dated 24.08.1983, whereby it had been decided that proficiency in typewriting of a prescribed minimum standard be made an essential qualification for direct recruitment to the post of Clerk in all the Departments. A copy of the said instructions dated 24.08.1983 is being appended at Annexure R-2 for the kind perusal of this Hon'ble Commission.

4. In view of the above the affidavit filed by the respondent appears to be convincing, hence no cause of action is left. Original affidavit alongwith annexure as submitted by the respondent be sent to the appellant alongwith these orders. Copy of the same is taken on record. *Moreover the appellant is advised, for her grievances, he may approach the higher authorities.*

5. In view of the foregoing, no cause of action is required, the appeal is therefore **disposed of and closed**. Copies of the order be sent to the parties.
