ORDER (FIRST HEARING):

The RTI application is dated 06.07.2021 vide which the Appellant has sought information from the PIO O/o District Manager, MARKFED, Fazilka in his RTI application as under: -

ਮੈਨੇਜਿੰਗ ਡਾਇਰੈਕਟਰ ਮਾਰਕਫੈਡ ਚੰਡੀਗੜ੍ਹ ਜੀ ਦੇ ਹੁਕਮ ਮੁਤਾਬਿਕ ਪੱਤਰ ਨੰਬਰ ਮਿਤੀ 22.10.2020 ਰਾਹੀਂ ਜਿਲ੍ਹਾ ਦਫਤਰ ਮਾਰਕਫੈਡ ਫਾਜ਼ਿਲਕਾ ਵਲੋਂ ਮੇਰੀ ਅਕਤੂਬਰ 2020 ਮਹੀਨੇ ਦੀ ਤਨਖਾਹ ਵਿਚੋਂ ਰਕਮ ਕੱਟਣੀ ਸ਼ੁਰੂ ਕਰ ਦਿੱਤੀ ਹੈ, ਮੇਰੀ ਜੁਰਮਾਨੇ ਦੀ ਕੁੱਲ ਕਿੰਨੀ ਰਕਮ ਬਣਦੀ ਹੈ ਅਤੇ ਮਿਤੀ 30.06.2021 ਤੱਕ ਕਿੰਨੀ ਰਕਮ ਦੀ ਕਟੌਤੀ ਕੀਤੀ ਗਈ ਹੈ ਅਤੇ ਕਿੰਨੀ ਰਕਮ ਕਟਣਯੋਗ ਬਕਾਇਆ ਰਹਿ ਗਈ ਹੈ, ਦਾ ਤਸਦੀਕਸ਼ੁਦਾ ਵੇਰਵਾ ਦੇਣ ਦੀ ਕ੍ਰਿਪਾਲਤਾ ਕੀਤੀ ਜਾਵੇ ਜੀ।

On not receiving information from the PIO or on filing First Appeal with the First Appellate Authority (hereinafter FAA) on 11.08.2021, the Appellant filed Second Appeal in the Commission on 06.10.2021 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and as such Notice of hearing was issued to the parties for 16.03.2022.

The case is fixed for today. The Respondent states that requisite information has already been provided to the appellant by hand. The Appellant confirms the receipt of information and gives his consent to close the case.

In view of the above, no further action is required in this Appeal case, hence this case is **disposed off and closed**. Copies of the order be sent to the parties.
