In case the appellant will submit the list of 10 Trucks along with name of the owner, then the record sought by him vide para no. 8 be provided to him and the appellant is directed that he should submit the list of the PIO within 10 days. Rest of the information sought by the appellant is either personal or between the office head and the employees. The appellant is to do nothing or no public interest is involved. So, all the other information is denied.
- 9. The information sought in this para is denied being vague.

I have also heard the SPIO on the show cause notice and he stated that the above said facts are in the knowledge of the Commission that the applicant filed vague application and voluminous in size. Such like information does not cover within the definition of information. Only that information which is in existence in the records of the public authority can be provided. After hearing the SPIO on the show cause notice I hereby withdraw the show cause notice issued to him.

In case the appellant submits as directed above the name of owners and number of vehicles then only that para of information be sent to the applicant through registered post and copy be sent to the Commission as compliance. Be come present on the next date of hearing on 7.07.2021 at 11.30 AM.
