The following order was made by this forum on 04.04.2019:

"The appellant had sought the information about the grants and the income that has accrued to the gram Panchayat of village Gunike and the amount spent on the various development works during the period from the year 2013 to 2018. The respondents have brought the entire record comprised in about 700 pages which has been handed over on spot to the appellant. The appellant points out that the copy of the record pertaining to the water supply is not included in the same.

The Commission has been made to understand that the above record is being maintained by the XEN, Rural Water Supply & Sanitation, Patiala. He is directed to provide him the information asked for before the next date of hearing. The respondents in the appeal shall duly intimate him about the above order of the Commission sufficiently in advance also of the next date of hearing."

"The case has come up today. Despite notice the respondents in the Department of Rural Water Supply & Sanitation, Punjab, has neither provided the information nor filed a written

His conduct seemingly is disdainful and defiant to the directions of the Commission. He has already rendered himself liable for imposition of penalty. However, in the

The case is being taken up today. Sh. Ram Das, JE, has submitted an affidavit of Sh. Jasinder Singh Sidhu, XEN, Water Supply and Sanitation, Division-1, Patiala. It has been stated that the former incumbent Sh. Baljit Singh has retired on 30.04.2019 and he has assumed the office on 03.05.2019. It has further been submitted that the water supply scheme in contention has since been handed over to Gram Panchayat of Gunike and the entire record pertaining to the scheme has been in custody of the former Sarpanch Smt Mandeep Kaur, W/o Sh. Jarnail Singh. Besides it has been submitted that they have made multiple attempts to impress upon the Sarpanch to hand over the sought for record to information seeker but in vain. In the course of discussion, it transpires that the appellant, Sh. Harjinder Singh himself has been the treasurer of the of the Water Supply and Sanitation Committee, whose task was to raise and collect bills and maintain the water supply in the village. The appellant did not disclose this fact during the course of hearing that he in a way has himself been the custodian of the record. Obviously, he has not approached the Commission with clean hands. The record available with the government offices has already been provided to him. The Commission feels that he has been sufficiently informed. Meanwhile, it directs the BDPO, Nabha, to ensure that the record in the custody of the former Sarpanch is transferred to its successors and the erring former Sarpanch is taken to task for the misconduct, if any.

The respondents have not as yet filed any reply/written statement to the notice issued

by the Commission. They are advised to do so with an advance copy to the appellant who may like to

react on the same in case she desires so".





### Appeal Case Nos.514, 515, 516 and 517 of 2019

Despite having passed express directions, the respondents have failed to file any written reply to the notice of the Commission. The appellant, on the other hand, citing the orders of Central Information Commission, insists that the respondents are a public authority and falls within the domain of RTI Act, 2005. Final opportunity is afforded to the respondents to put forward their view point, failing which the Commission shall pass an appropriate order based on the record on file.
