Today the case is heard through Video Conference facility available at the office of the Deputy Commissioner, Ludhiana. Both the parties are present today. I have discussed about the remaining information with both the parties.

Shri Navneet Joshi, First Appellate Authority-cum-BDPO, Malaud Distt. Ludhiana is present today and he stated that he has directed Shri Sukhpreet Singh, PIO-cum-Panchayat Secretary, Gram Panchayat, Ramgarh Sardaran, Tehsil Payal, Block Malaud, Distt. Ludhiana to provide the attested copies of information regarding point no.1 of the RTI application to the appellant, but the Panchayat Secretary stated that the information regarding point no.1 of the RTI application does not exist in the records of the Gram Panchayat, so he is unable to provide it to the appellant.

The Commission has received an e-mail sent by the PIO, which is a copy of letter dated 12.06.2020. I have gone through the said letter, which is reply to the Show Cause Notice issued to the PIO. The PIO submitted in the reply that he has provided the whole information to the appellant except information regarding point no.1 of the RTI application, which does not

exist in the records of the Gram Panchayat, Ramgarh Sardaran, so he is unable to provide it to the appellant. He further requested in the reply that the Show Cause Notice issued to him may please be dropped and filed.

The PIO stated that the appellant filed RTI application and he sought information regarding action taken on his application dated 09.09.2019. He further stated that regarding that application the office of the PIO has written letter no.131 dated 19.03.2020 to the Director, Health, Punjab for taking further necessary action. He further stated that the copy of letter no.131 dated 19.03.2020 has been provided to the appellant.
