2. The case has been heard today through Cisco Webex. Shri Khushal Chand Vohra, appellant has not come present to attend the hearing through Cisco Webex.
3. Inspector Avtar Singh, SHO, Police Station, Dera Baba Nanak, District Gurdaspur comes present to attend the hearing through Cisco Webex. He states that the appellant has sought CCTV footage of Police Station from 27.03.2019 to 07.04.2019.
