Appeal Case No. 31 of 2017

ORDER

1. The above mentioned case was last heard by the Special Bench headed by the undersigned on dated 14.05.2019 and order was reserved. Accordingly, the case was fixed for today i.e. 16.07.2019 for pronouncement of order.
2. Ms. Anita Darshi, PCS, who was respondent in this case had again brought to the notice of Hon'ble Chief Information Commissioner that two contradictory orders were passed by the then Ld. SIC, Sh. Alwinder Pal Singh Pakhoke on dated 12.10.2017 in this case.
3. In view of the above submission and the documents placed on record, it is observed that in the case file there is only one order dated 12.10.2017 signed by the then Ld. SIC, Sh. Alwinder Pal Singh Pakhoke through which penalty amounting Rs. 25,000/- was imposed on the respondent, Ms. Anita Darshi but she had produced order of the same date i.e. 12.10.2017 in the present case according to which Show Cause notice issued to her was withdrawn and case was disposed of & closed without imposing penalty on her.
4. After examining the case file and the position explained above, we are of the considered view that situation arised in this case is complicated due to two contradictory orders passed on the same date in the same case.

5. Therefore, it will be appropriate if this case will be heard by the Full Bench/Larger Bench.
Hence, **this case file is sent to the Deputy Registrar to place it before the Hon'ble Chief Information Commissioner for the appropriate orders.**
