He had neither sent any intimation regarding his non-availability nor sent any document, showing that the requisite information was supplied to the appellant. Accordingly, a penalty amount of Rs. 10,000/- was imposed upon the concerned PIO for making delay in supplying the requisite information to the information-seeker

Sh. Amritpal Singh, S. D. O., who appeared on behalf of the respondent PIO in today's hearing, complete information has been given to the appellant in person on 13.08.2021, appended to which is a note dated 13.08.2021 signed by the appellant as an acknowledgement of having received the requisite information, through which he claimed that he is satisfied with the information supplied and asked for filing of his case. It is taken on record.

The appellant, Sh. Lakhvir Kumar, who appeared in person in today's hearing, orally states that he received the requisite information.

# Appeal Case No. 2852 of 2020

After examining the documents placed on record, it emerges that the respondent PIO concerned has not complied with the orders dated 24.05.2021 passed by the Commission, through which a penalty of Rs. 10,000/- was imposed upon concerned PIO.
