- 4) ਇਹ ਹੈ ਕਿ ਹਰਬੰਸ ਸਿੰਘ ਤਹਿਸੀਲਦਾਰ ਖਿਲਾਫ ਮਹਿਕਮੇ ਵਿਚ ਕੌਮ ਕਰਦੇ ਹੋਏ ਲਾਪਰਵਾਹੀ ਕਰ, ਗਲਤ ਕੋਡ ਪਾ ਕੇ ਗਲਤ ਰਜਿਸਟਰੀ ਕਰਨ, ਪੁਰਾਣੇ ਅਸਟਾਮ ਲਗਾਕੇ ਸਰਕਾਰ ਦੇ ਮਾਲੀਏ ਨੂੰ ਨੁਕਸਾਨ ਪਹੁੰਚਾਉਣ ਤੇ ਇਲਾਵਾ ਹੋਰ ਜੋ ਵੀ ਵਿਭਾਗੀ ਕਾਰਵਾਈ ਕੀਤੀ ਗਈ ਹੈ ਅਤੇ ਜੋ ਵੀ ਵਿਭਾਗੀ ਕਾਰਵਾਈ ਚਲ ਰਹੀ ਹੈ ਉਸ ਦੌਰਾਨ ਜਾਰੀ ਹੋਏ ਪੱਤਰਾਂ ਦੀਆਂ ਫੋਟੋ ਕਾਪੀਆਂ ਦਿੱਤੀਆਂ ਜਾਣ।

3. The appellant states that the respondent-Public Information Officer may be directed to supply the remaining information pertaining to Point No. 3 and 4 of the RTI application. However, the representative of the respondents pleaded that the information cannot be

He further states that the said instructions were based on the decision given by the Hon'ble Supreme Court of India. The representative of the respondents also filed the specific reply in this regard along with the reply filed by the 3<sup>rd</sup> party i.e. Sh. Harbans Singh, Tehsildar pertaining to Point No. 3 of the RTI application. Regarding Point No. 4 of the RTI application, the reply of the respondent-Public Information Officer is reproduced below:-

4. Keeping in view the above, the plea taken by the respondent-Public Information Officer is accepted. Therefore, the Commission observes that no further action is required to be taken in this case.
