## Order:

The case was last heard on **08.07.2019.** The appellant claimed that despite order of the Commission, the PIO has not provided the information. The respondent was absent without intimation to the Commission. The PIO was issued a **show cause notice under Section 20 of the RTI Act 2005 and directed to file reply on** an affidavit.

The PIO was again directed to send a comprehensive reply on points-3&5 to the appellant within 10 days. A copy of the order was sent to the Superintending Engineer, PSPCL, Zirakpur Circle with a direction to resolve the matter.

## Hearing dated 16.10.2019:

The respondent present pleaded that the remaining information has been provided to the appellant and a copy of the same is submitted to the Commission. The appellant has received the information and is satisfied.

#### Order:

The appellant through RTI application dated 13.08.2018 sought copies of certain documents regarding case No.125/2014 registered at Police Station, Jamalpur On receiving no information, the appellant filed first appeal before the First Appellate Authority on 12.11.2018 and subsequently approached the Commission vide second appeal on 03.01.2019.

The case was first heard on 26.02.2019 by Sh.S.S.Channy, Chief Information Commissioner. The respondent denied the information stating that the matter is under investigation and challan has been filed in the court which was handed over to the appellant. The respondent also handed over a copy of judgement of the court in their defense to the appellant. The appellant handed over copies of four judgements in his support to the representative of the respondent. Both the parties were directed to furnish their reply to each other with a copy to the Commission.

The case was again heard by Sh.S.S.Channy, Chief Information Commissioner on 02.04.2019. The appellant submitted a letter which was taken on the record and a copy was handed over to the respondent. The respondent however failed to submit their reply on the judgements handed over to him by the appellant on 26.02.2019. The respondent was directed to file appropriate reply on the judgement and the letter submitted by the appellant.

The case was further heard on 08.07.2019. The respondent pleaded that the accused is in the judicial custody via order of Sh.Arunveer Vashist, Addl. Session Judge, Ludhiana in a double murder case of killing two persons. The respondent further informed that the appellant was working as a reader with Sh.Manjinder Singh, SHO in Police Station Machhiwara. Sh.Yadwinder Singh alongwith two other accused Sh.Manjinder Singh and Sh.Sukhvir Singh went on a raid in a case under the police station Jamalpur where due to heated arguments between both the parties, these accused killed two persons. Sh.Manjinder Singh and Sh.Sukhvir Singh have been declared P.O by the Court of Sh.Arunveer Vashist, Addl. Session Judge, Ludhiana. The statement of the respondent was taken on the file.

The appellant was absent and vide email has sought exemption being in judicial custody. The case was adjourned.

## Appeal Case No. 156 of 2019

The case was again heard on **29.07.2019**. The Commission observed that the appellant is a young under trial in a double murder case at Ludhiana, and is at present under custody at District Jail Rupnagar in FIR No. 125 dated 27.09.2014 u/s 302,148,149, 201 IPC PS Jamalpur, Ludhiana. The appellant sought to obtain copies of *Rojnamncha* and all the *Ziminies* of the Police file in the said FIR for his defense in the court. AS per facts, the challan in the present case has already been filled and thus the Investigations have been completed.

The Commission further observed that the respondent has not pleaded or has substantiated in any manner as to how by supplying the entire *zimini* file to the accused the prosecution shall get hampered. They have taken a blanket plea of an absolute bar, which is not available to them under the Law. The Judgments cited by the Appellant are very much applicable to the facts and circumstances of the present case, and the judgment cited by the Respondent pertain to section 24 of the RTI which is a special provision under which only those organizations fall which have been notified so, and admittedly Punjab Police does not enjoy the protection of Section 24 of the RTI Act.

That the "second" part of Section 8 (1) (h) of the Act is subjective and depends upon the facts and circumstances of each case.

Hence, given the circumstances of this particular case, the Commission was of the view that the disclosure of information rather than hampering prosecution may help the appellant to defend himself and in proving his innocence. The PIO was directed to provide all ziminies and all other information as sought in the RTI application within 10 days of receipt of this order.

The case was again heard on **13.08.2019.** The appellant claimed that the PIO has not provided the information. The respondent was absent and vide email has sought adjournment stating that all the staff is on duty for maintaining security and peace on the eve of independence day. The case was adjourned. The PIO was directed to provide the information to the appellant as per earlier order.

The case was last heard on **28.08.2019.** The respondent brought the information and handed over to the appellant. The appellant raised objection that the copies of the zimnies that were provided by the PIO, do not carry the signature of JMIC, Ludhiana. The appellant submitted a document where the Judge had made an observation that file of the investigation of this case has been perused and zimnies are also signed. The PIO was directed to provide photostat copies of those zimnies that have the signature of JMIC.

## Hearing dated 16.10.2019:

The respondent present pleaded that in compliance with the order of the Commission, the information has been provided to the appellant. The appellant has raised objection that the PIO has not provided the copies of rojnamcha from 27.09.2014 to 30.10.2014. The PIO is directed to remove the anomaly and provide the remaining information within 10 days.

ORDER:

The case was first heard on **25.06.2018**. The appellant was directed to visit the office of PIO and inspect the record and get the information he wants. The PIO was directed to provide information relating to point No.9 concerning their department i.e. only graph with name relating to point No.9 in CD and charge requisite cost or send through email.

The case was again heard on **01.08.2018**. The respondent pleaded that it is not possible for them to provide information in CD form as the information is of voluminous nature and it includes personal information of the applicants. After long discussions, the appellant asked that he does not need a CD and he can be provided a list of the successful applicants with application number. The PIO was directed to provide the same.

The case came up again for hearing on **05.09.2018.** The appellant was absent. The respondent present pleaded that he has brought the information regarding point No.9. The respondent was directed to send the same to the appellant through registered post. The PIO, O/o SDM was exempted for appearance on next hearing.

For the information regarding point No. 3,4 5 & 6, the RTI application was transferred to DTO Sangrur. The PIO, DTO Sangrur was directed to be present on the next date of hearing. The appellant was also directed to be present on the next date of hearing.

The case was again heard on **09.10.2018.** The appellant was absent and vide email informed that he has not received the remaining information. The PIO was also absent. The PIO-DTO Sangrur was granted one last opportunity to provide the information regarding points 3,4,5& 6 and be present personally on the next date of hearing with sold reasons for not complying the orders of the Commission.

The case again came for hearing on **21.11.2018**. Since the PIO-RTO Sangrur despite granting opportunities on 05.09.2018 and again on 09.10.2018, did not comply with the order of the Commission but preferred to be absent, the PIO-RTO Sangrur was issued a **show cause noticeunder Section 20 of the RTI Act 2005 and was directed** to appear before the Commission along with the written replies.

#### Appeal Case No. 1328 of 2018

The case was again heard on **15.01.2019.** The appellant informed that the PIO-RTA Sangrur has not provided the information. The PIO-RTA was absent nor sent any reply to the show cause. The PIO-RTA Sangrur was given last opportunity to be present personally or through a representative on the next date of hearing alongwith reply to the show cause notice on an affidavit. The PIO was also directed to provide the information to the appellant within 10 days and send a compliance report to the Commission.

On the next date of hearing which was held on **11.03.2019**, the PIO-RTA Sangrur was again absent nor provided the information to the appellant who was present on the date of hearing. The PIO was given one last opportunity to appear before the Commission on the next date of hearing alongwith reply to the show cause notice.

On the next date of hearing which was held on **01.05.2019**, both the parties were absent. The case was adjourned.

The case was last heard on **01.07.2019.** The appellant pleaded that through he has received the information but with a delay of one year and four months. The appellant claimed that he has been harassed a lot for not providing the information by the PIO in time and hence the PIO be penalized and he be compensated.

This was the 6<sup>th</sup> consecutive hearing that the PIO-RTA was absent despite many orders of the Commission, nor sent any reply to the show cause. Showing utter disregard for the Commission's repeated orders to provide the information as well as not replying to the show cause and not appearing before the Commission, a penalty of Rs.25000/- was imposed upon the PIO-RTA Sangrur which was to be deposited in the Govt Treasury.

The PIO-RTA Sangrur was also directed to pay an amount of Rs.2500/- via demand draft as compensation to the appellant for for the loss and detriment suffered by him of having to file the appeals and not getting the information in time. The PIO was directed to duly inform the Commission of the compliance of the order and submit proof of having compensated the appellant.

Further the PIO was also rendered liable under section 20(2) of the RTI Act and it was recommended to the Disciplinary Authority to issue a charge sheet to the PIO-RTA Sangrur for violation of the provisions of the RTI Act and send a copy to the Commission.

## Hearing dated 16.10.2019:

The PIO-RTA is present. The respondent pleaded that the delay in providing the information has occurred at the level of the clerk who did not put up the files on time.

The PIO is directed to file an affidavit in this regard on the next date of hearing.

To come up on 10.12.2019 at 11.00 AM for further hearing.
