This order may be read with reference to the previous order dated 17.09.2018.

2. The Respondent files his reply as under:-

2. The Appellant states that the Respondent has delayed in providing the information. Hence, he has suffered mental harassment.
3. The Respondent further states that the post of the PIO was vacant from the last few months. Therefore, the information was delayed.

4. After hearing the Respondent, it is observed that the post of the PIO was vacant in the office of the Respondent due to which the information could not be provided within time. Hence, taking a lenient view, the Respondent, is warned to be careful in future while dealing with the RTI Applications. In view of the foregoing, the Appeal case filed by the Appellant is **disposed off and closed**. Copy of the orders be sent to the parties.

**ORDER**

The brief fact of the case shows that the complainant filed his RTI on 05.01.2018 with the PIO, o/o DPI (Colleges), Punjab, Chandigarh. After not receiving any information, the Complainant filed RTI with the Commission on 12.03.2018. Notice of hearing was issued to both the parties for 30.04.2018 at 11.00 AM.

2. On 30.04.2018, the respondent was absent and the Complainant stated that no information has been given to him so far. Therefore, the case was adjourned on next date i.e. 16.05.2018. On 16.05.2018 Sh. Jai Singh Rana, Sr. Assistant was appeared and had sought some time. Therefore, the appeal was adjourned on 04.06.2018. On 04.06.2018, 02.07.2018 and 10.07.2018, neither the respondent was present nor has he bothered to inform the Commission about their absence. On that day, a show cause notice was issued to the PIO, o/o DPI (C), Punjab and the appeal was adjourned on 08.08.2018. On 08.08.2018 and 28.08.2018, again the respondent was absent. On 17.09.2018 again Sh. Jai Singh Rana appeared without any information.

3. In view of the above, it is observed that this is the Complainant and there is a decision of the Hon'ble Supreme Court of India rendered on 12.12.2011 in Civil Appeal Nos. 10787-10788 of 2011 (arising out of SLP© No. 32768-32769/2010) has held that while entertaining a complaint under Section 18 of the RTI Act 2005, the commissioners have no jurisdiction to pass an order providing for an access to the information. Since

the complainant has approached the Commission under the provisions of Section 18 of the RTI Act 2005, no directions for providing further information can be given by the Commission. The commission has to see the attitude of the respondent-PIO while dealing with the RTI application to an extent whether he is unable to supply the sought information under compelling circumstances or he is intentionally not supplying the information. In this case, it is derived that the respondent-PIO is intentionally delaying the supply of information and he has no respect for the orders of the Commission to be present, either himself or through his representative in the court.

4. In view of the defying attitude of the respondent-PIO neither attending the court nor submitting any explanation for the delay in supplying the information within the time schedule as prescribed under the RTI Act 2005, the court comes to a logical conclusion that it is a fit case for the imposition of penalty amounting to Rs. 25000/- (Rupees Twenty five thousand only) on the PIO. Therefore, taking a lenient view, I impose a penalty of **Rs. 5000/- (Rs. Five thousand only) on Mr. Harinder Singh Bhalla, Deputy Director-cum-PIO**. The Drawing and Disbursing Officer of the office of DPI(Colleges) is directed to deduct the amount of penalty of Rs. 5000/- from the salary of Mr. Harinder Singh Bhalla, Deputy Director-cum-PIO and deposited in the State Treasury in the following Head of Account and to report its compliance to the Commission:-

"0070-Other Administrative Services

60 other Services

800-Other Receipts

86-Fee under the RTI Act, 2005"

5. The perusal of the file also shows that Mr. Jai Singh Rana, Sr. Assistant had attended the hearings in the Commission, but he has not bothered to provide the information to the Complainant, which shows that he has no regard for the orders issued by the Commission. Therefore in this case he is treated as deemed PIO.

6. In view of the foregoing, Sh. Jai Singh Rana, Sr. Assistant (deemed PIO) is directed to show cause why action should not be taken against him for not providing the information to the Complainant within time. He should file a written reply In addition to the written reply PIO is hereby given an opportunity u/s 20(1) proviso thereto for a personal hearing before the imposition of such penalty on the next date of hearing. He may take note that in case he does not file his written reply and does not avail himself of the opportunity of personal hearing on the date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte.
