anything regarding Show Cause Notice and he will be penalized U/s 20(1) of the RTI Act, 2005.

The PIO is further directed that the information sought by the appellant be sent to him through registered post within a week.

Both the parties should personally come present on the next date of hearing on 19.11.2019 at 11:00 A.M.
