Ludhiana** that why the sought for information has not been provided to the applicant till date and so why he may not be penalized up to Rs. 25,000/-.

The SPIO is directed to file reply to the show cause notice in writing and send the same to the Commission within 10 days and an opportunity of personal hearing will be afforded to him on the show cause notice. In case the SPIO would not file reply to the show cause notice then it will be assumed that he do not want to say anything in his defense and the show cause

notice will be decided without hearing him and a penalty of Rs. 25,000/- will be imposed upon him.

The SPIO is further directed that the attested copies of sought for information be provided to the appellant before the next date of hearing and compliance be sent to the Commission accordingly.

Today the case is heard through CISCO Webex Meetings Software.

The applicant is present today, whereas Mr. Iqbal Singh, PIO-cum-Panchayat Secretary is absent without any intimation to the Commission.

The applicant has filed RTI application on 26.08.2020 and sought information regarding Gram Panchayat Bagrian, Tehsil and Distt. Fatehgarh Sahib, the village of the applicant. The applicant stated that till today Mr. Iqbal Singh, PIO-cum-Panchayat Secretary has not provided him the information neither he has provided the amount of compensation of Rs.5,000/-, which was awarded in his favour by the Commission.

I have gone through the case file. Mr. Iqbal Singh, PIO-cum-Panchayat Secretary, Gram Panchayat, Bagrian was present on the first date of hearing i.e. 25.02.2021 and after that on 24.03.2021, 04.05.2021, 23.06.2021, 24.08.2021 and 13.10.2021 he was absent and now today on 16.11.2021 he is again absent without any intimation to the Commission.

The conduct of Mr. Iqbal Singh, PIO-cum-Panchayat Secretary is highly condemnable and it shows disrespect towards the Orders passed by the Commission that he has appeared on only first date of hearing and after that on further dates of hearings he has never appeared before the Commission and as stated by the complainant/applicant no information has been provided to him.

I have gone through the order dated 13.10.2021 and Mr. Iqbal Singh, PIO-cum-Panchayat Secretary, Gram Panchayat Bagrian was directed to pay the amount of compensation of Rs.5,000/- to the applicant, He was further directed to file reply to the Show Cause Notice and an opportunity of personal hearing will be afforded to him on the next date of hearing. In case he would not file any reply to the Show Cause Notice, then it will be assumed that he do not want to say anything in his defence and the Show Cause Notice will be decided

on the basis of papers available in the file and a penalty of Rs. 25,000/- will be imposed upon him which will be deducted from his salary.

I have gone through the case file. Neither Mr. Iqbal Singh, PIO-cum-Panchayat Secretary has appeared for the hearing and nor he has sent any mail to the Commission. So, as per the facts mentioned above that the RTI application was filed on 26.08.2020 and a period of about 15 months has been passed, but no information has been provided to the applicant. Mr. Iqbal Singh, PIO-cum-Panchayat Secretary is not sincere towards his duties nor he has any respect for the law and the Commission. So, I impose a penalty of Rs.25,000/- upon him U/s 19(8) of the RTI Act, 2005, which will be deducted from his salary and be deposited in the Govt. Treasury in the following heads :-
