- 1. This order may be read with the reference of previous order 19.08.2021.
- Respondent, Sh. Jatinder Kumar stated that sought information is voluminous as it is pertaining to the period 01.04.2019 to15.12.2020, which makes it difficult for the PIO to collect the information and furnish it within the stipulated time.
