The RTI application is dated 10.07.2020 vide which the Complainant has sought information from the PIO O/o Sri Dashmesh Sr. Sec. School, Talwandi Sabo, District Bathinda in his RTI application as under: -

6. ਮੋਜੂਦਾ ਪ੍ਰਿੰਸੀਪਲ ਵੱਲੋਂ ਸਕੂਲ ਵਿਖੇ ਬਤੌਰ ਪ੍ਰਿੰਸੀਪਲ ਦੀ ਪੋਸਟ ਤੇ ਭਰਤੀ ਹੋਣ ਲਈ ਅਪਲਾਈ ਕਰਨ ਸਮੇਂ ਦਿੱਤੀ ਦਰਖਾਸਤ ਅਤੇ ਉਸ ਦਰਖਾਸਤ ਨਾਲ ਨੱਥੀ ਕੀਤੇ ਦਸਤਾਵੇਜ਼ ਮੋਜੂਦਾ ਪੋਸਟ ਤੇ ਭਰਤੀ ਹੋਣ ਤੋਂ ਪਹਿਲਾਂ ਦੇ ਆਪਣੇ ਤਜਰਬੇ ਸਬੰਧੀ ਲਗਾਏ ਗਏ ਸਰਟੀਫਿਕੇਟ/ਦਸਤਾਵੇਜ਼ ਦੀਆਂ ਤਸਦੀਕਸ਼ੁਦਾ ਕਾਪੀਆਂ ਦਿੱਤੀਆਂ ਜਾਣ ਜੀ।

When no information has been received from the PIO, he has filed Complaint in the Commission on 21.08.2020 under Section 18 of the Right to Information Act, 2005 (hereinafter RTI Act) and as such Notice of hearing was issued to the parties for 28.10.2020.

During the hearing dated 28.10.2020, *the Respondent attended the hearing through Webex and he has also sent a written submission in the Commission vide diary no. 14615, dated 22.10.2020 mentioning therein that Sri Dashmesh Sr. Sec. School Talwandi Sabo is a purely unaided private school being run by its Management which is vested in its Managing Committee. He further added that since an unaided private school does not fall within the purview of the instrumentality under Article 12 of the Constitution of India and as such the question for bringing it within the scope of the provisions of Right to Information Act, 2005 does not arise whereas the Complainant was absent.*

In view of the above, the Respondent is directed to send this reply to the Complainant today through registered post, under intimation to the Commission.

The Complainant is also directed to file replication, after receiving the same and follow up his case in the Commission, failing which appropriate decision shall be taken in his absence.

The matter is taken up today. The Respondent states that he has sent the reply/information to the Complaint vide letter dated 13.11.2020 through registered post but no deficiencies pointed out by the Complainant. The Complainant is absent on the Webex and he subsequently contacted on the mobile phone and he states that sufficient reply/information has been provided to him and gives his consent to close the case. Therefore, no further action is required in this case, hence, the instant Complaint Case is hereby, **disposed of and closed**. Copies of the order be sent to the parties.
