ORDER

1. The above mentioned case was last heard by the bench of Ld. SIC, Sh. Yashvir Mahajan dated 03.09.2019 and this case was allotted to the bench of undersigned vide Office Order dated 08.11.2019 passed by the Hon'ble Chief Information Commissioner, Punjab. Accordingly, the case is fixed for hearing today.

2. Respondent, Sh. Naresh Kumar states that requisite information has already been supplied to the appellant.

3. Appellant, Ms. Renu Sharma states that respondent PIO had not supplied the complete information. She presented supplied information before the Commission and bring into the notice of the Commission that respondent PIO has supplied bills after pasting the pages in between and due to it full information of the bills are not visible

4. After hearing both the parties and examining the case file, it is observed that forged bills have been supplied to the appellant by the respondent. A last and final opportunity is given to the respondent PIO to supply the point-wise complete requisite information to the appellant before the next date of hearing. He is also directed to bring the original record along with a copy of the supplied information on the next date of hearing, failing to which stern action will be initiated against him. He is also directed to file a reply to Show Cause notice issued to him vide order of the Commission dated 23.01.2018.

5. I am of the view that due to evasive attitude of the respondent PIO concerned, the appellant has suffered a lot of detriments for not getting the requisite information, I am of the view that compensation be awarded to the appellant, Ms. Renu Sharma.

Hence, I award a compensation of Rs. 2,000/- (Two Thousand Only) to the appellant. The compensation amount must be paid by the respondent PIO concerned through cheque or demand draft in favor of **Renu Sharma** from the account of Public Authority and not from the individual's account.

Respondent PIO is directed to produce a copy of the cheque or demand draft on the next date of hearing.

6. In view of the defying attitude of the respondent PIO neither attending the court nor submitting any explanation for the delay in supplying the information within the time schedule as prescribed under the RTI Act 2005, the court comes to a logical conclusion that it is a fit case for the imposition of penalty amounting to Rs. 25,000/- (Rupees Twenty Five thousand only) on the PIO. Therefore, taking a lenient view, I impose a penalty of **Rs. 10,000/- (Rs. Ten Thousand Only) on the concerned respondent PIO, Sh. Naresh Kumar, Office of BDPO, Talwara.** The Drawing and Disbursing Officer of the office of the Additional Deputy Commissioner (General), Hoshiarpur is directed to deduct the amount of penalty of Rs. 10,000/- from the salary of the concerned respondent PIO and deposited in the State Treasury in the following Head of Account and to report its compliance to the Commission:-

“0070-Other Administrative Services

60 other Services

800-Other Receipts

86-Fee under the RTI Act, 2005”

7. The perusal of the file also shows that respondent PIO, **Sh. Naresh Kumar** has no regard for the Notice and Orders issued by the Commission. A copy of this order be sent to him by name through **registered post** for his ready reference along with directions to appear in person on the next date of hearing.
