2. The appellant is absent without intimation.
3. The representative of the respondents-Panchayats Secretary states that information regarding point at Sr. No.6 concerning panchayat-Ganga Kala has been sent to the appellant through registered post.
4. After hearing the representative of the respondent-PIO-Shri Sukhdeep Singh, Panchayats Secretary, it is observed that information relating to the concerned panchayat has been supplied. The appellant is advised to revert back to the respondent-public authority in case of deficiencies in the information supplied to him regarding concerned panchayat.
