The case was again heard on **28.08.2019.** The appellant informed that the information regarding points 3,4& 7 is not received. The PIO-RTA Ferozepur and PIO-STC were absent. The PIO-RTA Ferozepur and PIO-STC were given one more opportunity to provide the information concerning them as per earlier order and appear personally on the next date of hearing. A copy of RTI application was enclosed with the order for PIO-RTA Ferozepur.

The case was last heard on **02.12.2019.** Both the parties were absent. The PIO-RTA Ferozepur and PIO-STC were given one last opportunity to comply with the order of the Commission and be present on the next date of hearing otherwise the Commission will be constrained to issue a show cause notice under section 20 of the RTI Act.

#### Hearing dated 17.02.2020:

The respondent present pleaded that the information has been provided to the appellant and a copy of the same is submitted to the Commission. The appellant has received the information and is satisfied.

Since the information has been provided, no further course of action is required. The case is **disposed off and closed**.
