2. Appellant, Sh. Sukhwinder Singh stated with the compliance of the previous order of the commission he visited the respondent's office dated 10.03.2021 for record inspection but the respondent authority failed to offer inspection.



3. On other hand the Respondent, Sh. Balwinder Singh pleaded that appellant has not visited the office for record inspection. He further added that the requisite information has been prepared/ready and the appellant can come and collect the same. A written submission in this regard has been made by the respondent authority in the Court.

4. **Decision:**

Keeping in view the facts of the case and going through the RTI application the Commission directs the appellant is to collect the sought information from the respondent's office by proper **tie-up** with the concerned officials.

The PIO is however, cautioned to exercise due care in future to ensure that correct and complete information is furnished timely to the RTI applicant(s) as per provisions of the Act failing which penal proceedings under section 20 shall be initiated.

The Appeal stands disposed with the above direction.

- b) Please provide me the entire attested copies of the Authority letters or proceedings issued by the office of Defendant No- 2 of Civil Suit No- 2083 of 2015 i.e Principal Secretary (Health and Family) Welfare, Punjab for allowing Dr. Nirlap Kaur (Deputy Director) Dental cum Inquiry Officer, Punjab and Inquiry Committee for not to conduct any fresh inquiry on Point No- 1 of COS, Punjab Notice No- 7328 dated 18/05/2015 (Exhibit P-7 of the Court File) which reads as " For Your Personnel Interest you filed many false complaints in the various Departments including this office and the Department of Health.
