## ORDER

The RTI application is dated 17.8.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 22.10.2020 and second appeal was filed in the Commission on 9.3.2021 undeR Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The appellant has sought the following information:-

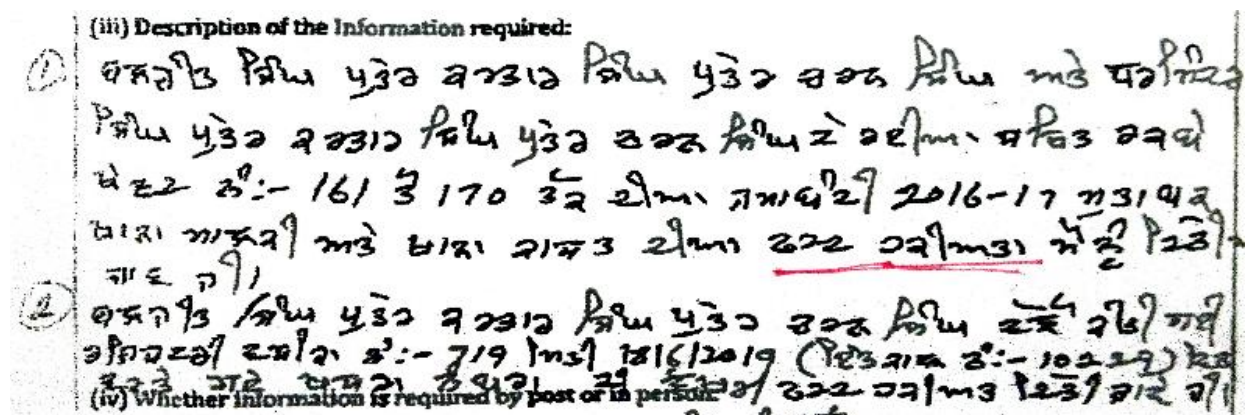

ORDER

The RTI application is dated 23.11.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 8.1.2021 and second appeal was filed in the Commission on 10.3.2021 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today i.e. 17.5.2021.

2. The appellant has sought the following information:-



2 The appellant states that incomplete information has been provided by the respondent and concerned Patwari is misleading the Commission. He further states that he has sent a letter dated 30.3.2021 addressed to the Tehsildar Baba Bakala informing him about the deficiencies in the Farad Hakiata ("ਫਰਾਦ ਹਾਕੀਆਤਾ") sent by the concerned Patwari Shri Mandip Singh. He has requested the Commission to direct the respondents to supply the complete information. He has also sent the submissions on 11.5.2021 to the Commission in this regard, which are taken on the record.

3. The representative of the respondent states that the sought information pertaining to Farad Hakiata ("ਫਰਾਦ ਹਾਕੀਆਤਾ") by the appellant is required to be created on the basis of Jamabandi and the same is not part and parcel of the official record. He further clarified that the appellant has to apply separately in case he wishes to get the Farad Hakiata ("ਫਰਾਦ ਹਾਕੀਆਤਾ"). He further states that even though the Patwari has made available the copy of Farad and Fard Hakiata ("ਫਰਾਦ ਹਾਕੀਆਤਾ") to the appellant. Thereafter the appellant states that he has sent a letter dated 23.3.2021 by post in which the deficiencies have been

pointed out in the Farad Hakiata ("ਫਰਦ ਹਕੀਅਤਾ") and requested to direct the respondents to supply the information regarding the complaint. Regarding the letter of the appellant dated 23.3.2021, the respondent-Public Information Officer states that the appellant may file the separate request and the same will be provided to him within a week as the same is not the part and parcel of the present case.

4. After deliberations, the submissions of the Naib Tehsildar is accepted and the appellant is hereby, advised to file the fresh application in case he is willing to get the information pertaining to letter dated 23.3.2021 and the respondents will provide the same within a week as has been assured by him. As far as the information is concerned, the complete information has already been supplied by the respondents in this case, therefore, the Commission observes that no further action is required to be taken in this case. Hence, this case is disposed of and closed.
