1. The RTI application is dated 14.11.2019 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 20.12.2019 and the second appeal was filed in the Commission on 02.03.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. Notice of hearing was issued to the parties for 17.06.2020 by the Commission through Video Conferencing facility in the office of D.C. Jalandhar.
3. The appellant comes present in person before the Bench in Commission 's office at Chandigarh. He states that no information has been supplied to him so far.
4. Neither the PIO himself has come present to attend the hearing through V.C. nor he has deputed any of his representative to attend the hearing on behalf of the PIO.
5. The Bench observes that RTI application is dated 14.11.2019 and even after a lapse of more than 6 months, no information has been provided to the appellant nor the PIO has bothered to send any intimation to the Commission in this regard. The Bench takes serious note of the absence of PIO.
6. The PIO O/o Secretary, Regional Transport Authority, Jalandhar is issued show cause notice to explain his absence and to explain as to why action should not be taken against him and also as to why penalty should not be imposed in the instant case for not supplying the information to the appellant. He is also directed to file a written reply to the show cause notice as to why the appellant should not be compensated for the mental harassment suffered by him in getting the information.

7. In addition to the written reply, PIO is hereby given an opportunity u/s 20(1) proviso thereto for a personal hearing before the imposition of such a penalty, on the next date of hearing. He may take note that in case he does not file the written reply and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceeding against him ex-parte. The PIO is directed to come in person on the next date of hearing.

1. This order may be read with reference to the order dated 26.02.2020 passed by this Bench on the previous date of hearing.
2. The case has been heard today through Video Conferencing facility at Amritsar. The appellant Shri Jaswant Sarpal attends the hearing through V.C. He states that no information has been supplied to him so far.
3. Shri Raj Anthony, Sub Fire Officer attends the hearing through VC on behalf of the PIO. On the asking of the Bench, the APIO present does not know the case and gives response not related to the case. This approach from the respondent of a Government Department is unacceptable and viewed adversely by the Bench.
4. The Bench also observes that on the last date of hearing, show cause notice was issued to the PIO O/o Commissioner, Municipal Corporation, Amritsar, but no reply has been filed to the show cause notice. The Bench takes serious note of the casual attitude of the PIO. It is true that no information has been supplied to the appellant. For the loss and detriment suffered by the appellant during this long period in obtaining the information in the instant case, I find full justification in awarding him suitable compensation.
