**ORDER**

1. The RTI application is dated 23.01.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 18.12.2019 and second appeal was filed in the Commission on 04.03.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. Notice of hearing was issued to the parties for 15.04.2020. But due to lockdown on 15.04.2020 the aforementioned Appeal case was postponed and fixed for hearing on 16.06.2020 i.e, today through CISCO Webex, but both the parties were unable to install the CISCO-WEBEX app hence, they requested to attend the hearing in the Commission office. 3. The complainant states that no information has been given to him so far.

Padam Dass, Sr. Assistant, appearing on behalf of the Respondent is not aware of the facts of the case. This is a serious matter. Hence, Sh. Ravinder Garg, Assistant Deputy Director is directed to come present on the next date of hearing with point-wise reply, failing which action under Section 20 (1) of the RTI Act will be initiated.
