**In view of the above, a penalty of Rs. 2,500/- (Rupees Two Thousand and Five Hundred Only) is imposed on the concerned PIO/Respondent, O/o Regional Transport Authority, Patiala (Punjab). The amount of penalty i.e. Rs. 2,500/-**

**should be deducted from the salary of the PIO and be deposited in the Govt. Treasury under the head “0070-Other Administrative Services-60-Other Services-800-Other Receipts-86-Fees under the Right to Information Act”.**

The PIO is also directed to come in person and submit the proof of having deposited the penalty on the next date of hearing. PIO is further directed to supply the complete information to the Appellant on/before the next date of hearing.

All the parties are directed to appear on the next date of hearing.

**The case is adjourned to next date of hearing which is fixed for 09.09.2019 at 11.00 AM.**

### **ORDER:**

After considering all those documents and on the basis of the recorded statements; the enquiry report has been made which consists of six pages and that has been supplied to her.

On this, the Appellant, Ms. Kulwant Kaur, is not satisfied with the supplied information. She admits that she has received the enquiry report i.e. 6 pages but she wants the attested copies of the documents like Jamabandi, mutation etc. which had been demanded from her at the time recording of statements.

After going through the case file and discussing with both the parties it has been observed that the Appellant is asking for those attested paper/documents which have been submitted by her (self attested) for making the enquiry report, which is not possible as she has received the desired information as per her RTI Application dated 15.02.2018, in which she has only requested for the enquiry report.

While discussing, it is further observed that the Appellant is not satisfied with this as she is reiterating her earlier statements in the Court and asking for her own self attested papers which she has self submitted.

**As per the RTI application the information has already been supplied to the Appellant. So, no further intervention is called for. In view of above, this case is disposed of and closed.**
