He is hereby required to file an affidavit about his position and explain as to why taking it as a violation under Section 7 (1) of the Act, a penalty under Section 20(1) should not be imposed on him. Meanwhile, it should be ensured that the documents sought are arranged to be provided as directed earlier to the information seeker positively."

"The case has again come up for hearing today. The appellant is not present. The respondents have failed to come up with any convincing response. A last opportunity is afforded to them to comply with the order of the Commission.

The case has again come up today for hearing. It is very strange and intriguing that despite the express directions followed by a show cause notice to the PIO, in O/o Department of Local Government (LG - 1 Br.), he has maintained a stony silence. The Commission is inclined to believe that Sh. Harjit Singh, PIO - cum - Superintendent is malafidely and willfully withholding the information and defying the order of the Commission. A final opportunity is afforded to him to comply with the directions passed by the Commission. Be it noted that he is already under the show cause notice of imposition of penalty."

17.07.2019

This is a very long standing case. The original application was filed by the appellant on 24.05.2017. Ever since the Commission has passed umpteen directions and even issued a show cause notice to the PIO. However, he has failed to respond much less supplying the information. The Commission finds that the PIO is defiant and has refused to part with the information in violation of the provisions of Section 7(1) of the RTI Act, 2005.

The delay is beyond 100 days. While exercising its authority under Section 20(1) of the RTI Act, the Commission imposes a penalty of Rs25,000/- on the Superintendent, Shri Harjit Singh which shall be recovered from his salary, commencing from the month of August, 2019 in five equal installments each month by his DDO, under intimation to the Commission. It shall be deposited in the Govt. treasury under the head: - 0070-Other Administrative Services- 60 Other Services- 800 Other Receipts- 86 Fee under RTI Act, 2005. A copy of the challan shall be sent to the Commission for record immediately.3

The Commission observes that the PIO has shown complete disregard to the statutory authority and its directions. He has shown grave indiscipline and misconduct. We direct to his appointing authority to initiate disciplinary action against him under Punjab Civil Services (Punishment & Appeal) Rules, 1970 and a copy of the charge sheet thus issued be sent to the Commission for record.

The appellant has been put to a lot of harassment over a period of last more than two years. Compensation to an extent of Rs.5,000/- is awarded for the detriment suffered by him. It shall be paid by the public authority from its account by way of demand draft in favour of the appellant within a month of the receipt of the order positively.

The information still has not been provided, the Commission further directs the PIO to come along with the original record in the office of Commission on the next date of hearing failing which his presence shall be ensured by exercising its authority under Section 18(7) of the Act.

The representative from the office of Chief Director, Vigilance Bureau may not attend the proceedings as the record in question is no more under their control.
