The amount of penalty i.e. Rs. 10,000/- should be deducted from the salary of concerned PIO O/o Food Safety, Moga, and be deposited in the Government treasury under head 0070-Other Administrative Services-60-Other Services-800-Other Receipts-86-Fees under the Right to Information Act.
- 6. The Civil Surgeon shall ensure that this amount of penalty is deducted from the salary of the above said concerned defaulting official(s) and deposited in the Treasury under the relevant head and issue instructions to his official(s) to present the Challan and/or relevant evidence(s) before the Commission on next date of hearing positively. <u>The Civil Surgeon Moga is also directed to disclose the Name and other details of concerned defaulting officer (PIO) to the Commission and also represent this case in person or through his/her representative on next date of hearing.</u>
