**ORDER**

1. This order may be read with reference to the order dated 27.07.2020 passed by this Bench on the previous date of hearing..
2. The case has been heard today through Cisco Webex. The appellant Shri Shakti Bhushan attends the hearing through CISCO Webex. He states that neither any information has been provided to him nor any communication has been received from the PIO regarding inspection of the records to enable him to identify the information. .
3. Nobody from the office of Motor Vehicle Registration Authority, Hoshiarpur has come present to attend the hearing through Cisco Webex. 3. The case was scheduled to be heard today through Cisco Webex. The appellant Shri Vinod Kumar did not attend the hearing through CISCO Webex.

4. Smt.Sarabjit Kaur, APIO, O/o Punjab State Board of Technical Education & Industrial Training, Sector-36, Chandigarh/APIO comes present in person before the Bench. She states that the appellant has been sent reply vide letter dated 16.01.2020 and again vide registered letter dated 07.08.2020 to the effect that the information sought relates to third party and cannot be supplied as per provisions of Section 8(i)(j) of the RTI Act, 2005. She further states the same has also been intimated to the Commission vide letter dated 07.08.2020.

5. Shri Vinod Kumar, appellant is contacted on mobile phone and he is apprised of the position explained by the APIO. He admits receipt of letter dated 16.01.2020, but he expresses his concern over the fake Pharmacy degree obtained by the person concerned with the Registration No. quoted by him. The issue is discussed and explained in detail to the appellant. He is told that as per documents shown by the APIO, the concerned person holds a valid degree, however, the information has been rightly denied to him under Section 8(i)(j) of the RTI Act, 2005 as it serves no public activity or interest.

6. In view of the above, no further cause of action is left in the matter. **The Appeal Case is disposed off and closed.** Copies of the order be sent to the concerned parties.

**ORDER**

1. The RTI application is dated 13.12.2019 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 10.01.2020 and the second appeal was filed in the Commission on 20.02.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. Notice of hearing was issued to the parties for 17.08.2020 by the Commission to attend the hearing before the Bench.
3. Shri Piara Singh, Assistant Transport Officer O/o S.T.C. Punjab, Chandigarh attends the hearing in person before the Bench. He produces letter dated 14.08.2020 before the Bench vide which information has been sent to the appellant. He further states that the information had also been sent earlier vide letter dated 12.02.2020. He observes that no enquiry into the complaint received against the appellant has been got conducted so far. As such, no information regarding the conduct of enquiry can be supplied.
4. The appellant is not fully satisfied by the information given so far.
5. On the asking of the Bench, the PIO reads out the contents of point wise reply dated 12.02.2020. The Bench informs the appellant that information supplied is in order. The appellant states that he

had pointed out deficiencies to the PIO vide his letter dated 13.02.2020. The appellant further states that though he is convinced that no enquiry has been conducted into the complaint so far, he requests that a copy of the letter written to the complainant asking for the documents as evidence against the appellant be given to him.

6. The Bench directs the PIO that a copy of the letter written by the office of S.T.C. Punjab to the complainant, as pointed out by the appellant, be supplied to him within next seven days. The PIO assures to do the needful.

7. With these directions, no further action is called for in the matter. **The Appeal Case is disposed off and closed.** Copies of the order be sent to the concerned parties.
