ORDER

This order may be read with reference to the previous order dated 19.7.2021.

2. The appellant is apprised with the decision of the Hon'ble Supreme Court of India Dated: 12.12.2011 in Civil Appeal Nos.10787 – 10788 of 2011 (arising out of SLP @ No.32768-32769/2010) in which it has held that while entertaining a complaint under Section 18 of the RTI Act, 2005, the Commissioners have no jurisdiction to pass an order providing for an access to the information. Since the complainant has approached the Commission under the provisions of Section 18 of the RTI Act, 2005, no directions for providing further information can be given by the Commission.

An alternative and efficacious remedy of first appeal is available to the complainant under Section 19(1) of the RTI Act, 2005 which has not been availed in the instant case.

3. However, the appellant states that he does not want to get the information rather he has requested to take appropriate action against the respondent-Public Information Officer as per the provisions of the RTI Act, 2005.

4. Accordingly, the respondent-Public Information Officer is directed to file the reply that why the information has not been supplied to the appellant within stipulated period as per the provisions of the RTI Act, 2005 ?
