



"...ਆਪ ਵੱਲੋਂ ਮੰਗੀ ਗਈ ਸੂਚਨਾਂ ਲੜੀ ਨੰ: 1,1,3,4 ਵਿੱਚ ਦਰਜ ਪੱਤਰ ਇਸ ਦਫਤਰ ਦੇ ਡਾਇਰੀ ਰਜਿਸਟਰ ਵਿੱਚ ਪ੍ਰਾਪਤ ਨਹੀਂ ਹੋਏ। ਇਸ ਕਰਕੇ ਇਹ ਸੂਚਨਾਂ ਨਹੀਂ ਦਿੱਤੀ ਜਾ ਸਕਦੀ।"

- 4. However, the appellant is also apprised with the decision of the Hon'ble Supreme Court of India Dated: 12.12.2011 in Civil Appeal Nos.10787 10788 of 2011 (arising out of SLP © No.32768-32769/2010) in which it has held that while entertaining a complaint under Section 18 of the RTI Act, 2005, the Commissioners have no jurisdiction to pass an order providing for an access to the information.
- 5. Keeping in view the specific reply filed by the respondent-Public Information Officer referred to above, the Commission observes that no further action is required to be taken in this case. Hence, the case is disposed of and closed.
